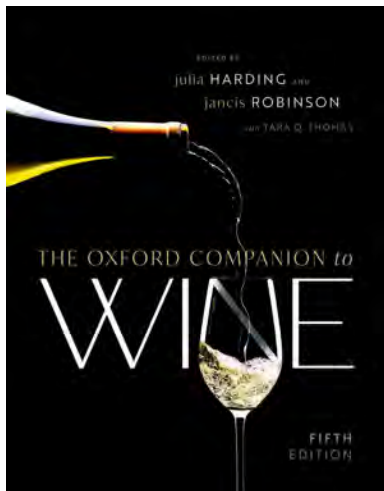

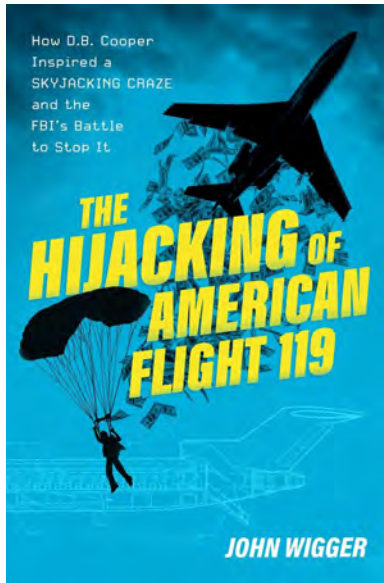

## The Hijacking of American Flight 119

How D.B. Cooper Inspired a Skyjacking Craze and the FBI's Battle to Stop It

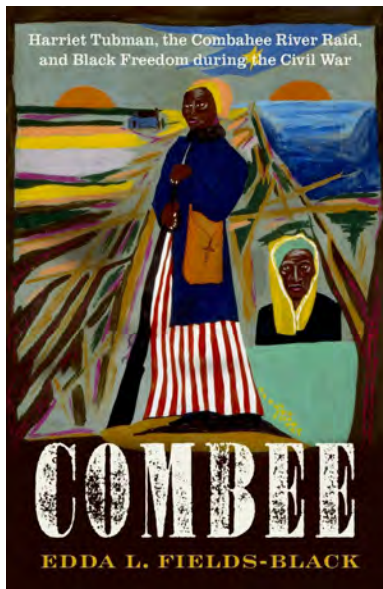

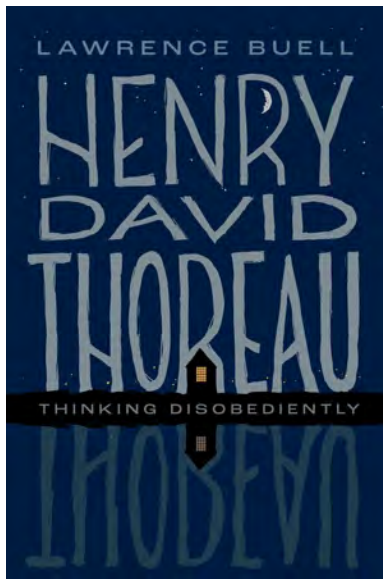

Her determination to illuminate the riches of the Gullah dialect, and to reclaim Gullah Geechee history and culture, has taken her to the rice fields of South Carolina and Georgia to those of Sierra Leone and Republic of Guinea in West Africa.

## Dancing with the Devil

Worms are just as much a part of the garden as the flowers, and their presence means your garden is thriving. Gardens aren't better off without their worms, and neither are we. The trick is learning how to enjoy our gardens, worms and all.

Thomason draws on insights from the history of philosophy to show what we've gotten wrong about bad feelings and to show readers how we can live better with them. There is nothing wrong with negative emotions per se. Their bad reputation is undeserved. Their fallout has led central banks to create over \$25 trillion of new money, brought about a new age of geopolitical competition, destabilised the Middle East, ruptured the European Union, and exposed old political fault lines in the United States.

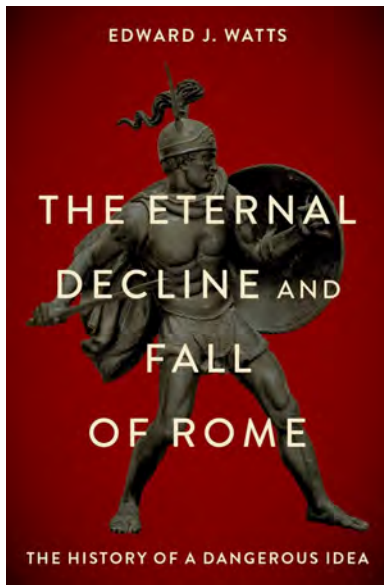
